Please note that if you are requesting the opportunity to inspect records, you will be requested to make an appointment to return at a later date/time to view the documents.

Charges for the direct cost of duplication will apply. **Documents will not be copied until payment has been received.** If payment is not received within 10 days after invoice is sent, you may be required to submit a new request. Please see backside for additional information.

The City of Anaheim Public Utilities Department (APUD) has a program to improve service reliability for our customers. The project calls for installing new underground 12kV ductbank along:

- Harbor Blvd.: from Katella Ave to south of freeway 5
- Manchester Ave.: from Harbor Blvd. to Clementine St.
- Disney Way: from Harbor Blvd. to Haster St.
- Clementine St.: from Katella Ave. to Manchester Ave.
- Zeyn St.: from Katella Ave. to Disney Way
- Haster St.: from Gene Autry Way to east of freeway 5
- Katella Ave.: from Harbor Blvd. to east of Anaheim Way

Henkels & McCoy has now been retained by the APUD to act on its behalf in procuring the acquisition of existing and proposed underground substructure maps showing the size and location of facilities within and around the project area. The information will be used in the creation of construction drawings for the Electric Reliability Improvement project in the Central Anaheim area.
