RE: Design-Build Master Agreement for Water, Wastewater, and Storm Water Projects

FOR INFORMATION ONLY, the Department of Public Works is advertising for qualifications to perform as-needed design, construction, upgrade, alteration, and repair of new and existing water, wastewater, and storm water systems and facilities under a Design-Build Master Agreement.

Prequalified Design-Builders will be required to execute a Master Agreement and, with City Council approval, will be eligible to submit proposals for Work Order Packages issued pursuant to the Master Agreement. Work Order Packages awarded under this Master Agreement will include, but not be limited to the design, upgrade, construction, alteration, and repair of new and existing water, wastewater and storm water systems and facilities throughout the City. Specific work includes abandon, repair, relocate, replace, and install general pipeline infrastructure components; including pipelines, valves, manholes, pressure reducing stations, water meters and vaults.

Work Order Packages may include covered "Project Work" as defined in the CWA. For applicable Work Order Packages, the awarded Design-Builder and its subcontractors of all tiers shall agree to execute and be bound by the terms of the CWA by signing a Letter of Assent (a form attached to the CWA as Attachment A). The CWA will be incorporated by reference in the Design-Build Master Agreement and can be accessed on the City's website at: <http://anaheim.net/229/Public-Works>.

Funding Source(s): Funding sources are anticipated to include Water Capital for Water Mains, City Storm Water Funds, City Wastewater Funds, and others as appropriate. Work Order Packages will be budgeted in the Public Works Department Capital Improvement Program and Public Utilities Department Water Capital Improvement Program for each fiscal year.

Required license classifications: "A" General Engineering, "C34" Pipeline Contractor, or "C42" Sanitation System Contractor classifications as listed in the Request for Qualifications. DIR registration is required for prime and subcontractors.

No bid bond required. Liquidated Damages will be assigned and determined as per Work Order Package.

A NON-MANDATORY Pre-Submittal Meeting is scheduled for Monday, June 15, 2020, at 10:30am. Call in details will be listed on the online bidding platform.
