Registered Lobbyist Annual Report: Calendar Year 2020

A. Background

On August 15, 2017, the City Council of the City of Anaheim adopted Ordinance No. 6417, which became effective on September 14, 2017. This ordinance includes a “Sunshine” provision which implemented the Lobbyist Registration Program. This program requires an individual or entity, who receives compensation of \$500 or more in a calendar month for lobbying in the City of Anaheim or any regional agency in which Anaheim has a voting role, to register with the City Clerk as a lobbyist.

To ensure complete public disclosure of the range of activities by lobbyists and those who employ them, lobbying entities are required to file quarterly disclosure reports. Pursuant to Section 1.11.070.050 of the Anaheim Municipal Code, an Annual Report is submitted to City Council outlining the lobbying activity, as reported. This report summarizes the lobbyist activity as disclosed in reports filed for Quarters 1, 2, 3 and 4 of calendar year 2020.

B. Registration

Lobbyists/Lobbying Firms are required to register with the City Clerk within fifteen (15) days of lobbying the City of Anaheim or any regional agency in which Anaheim has a voting role. During calendar year 2020, there were a total of 18 active/registered lobbyists within the City. Below reflects lobbyist who registered and/or added clients to the registry in 2020:
