- The Anaheim Housing Authority will be accepting 10,000 pre-applications to its Section 8 program waiting list. The Section 8 program, also known as the Housing Choice Voucher program, provides rental assistance to eligible low-income families, which helps them afford safe, quality housing.
- *Applicants can apply using any electronic device with internet access. To apply, you will need a valid email address.
- A lottery will determine which 10,000 pre-applications will be admitted to the waiting list. Veterans and individuals who live or work in Anaheim will be given a preference. A lottery in each preference group will randomly determine which pre-applications will be accepted and their order of placement on the list.
- The pre-application is available 24 hours a day during the application period and the lottery is not affected by the date you apply.
- Applicants will be notified of their lottery selection status by email by May 11, 2023.
